5. COVID-19 Implications on Board Business/Meetings:

Superintendent Taylor reported that there is discussion on-going with the Ministry, regarding byelections with some districts choosing to postpone their by-election. Superintendent Taylor presented the pros and cons of postponing the SD10 Central Attendance Zone By-Election.

Superintendent Taylor acknowledged that the SOGI Policy Committee is a larger than normal group for a Policy Committee.

Board Chair Brekke and Superintendent Taylor reported that the Board and the District have existing Policy language and that the purpose of the committee is to modernize language, so it is not a matter of the Board/District being without a SOGI Policy.

Assistant Secretary-Treasurer S. Woolf reported to the Board that the changing landscape as a result of the current pandemic, is likely to have an impact on the budget and that there would be benefits to continuing with the finance committee work.

Superintendent Taylor reported that annual budgets are not due until the end of June which provides for some flexibility in scheduling. Superintendent Taylor reported that there are certain advantages in proceeding with the finance committee work in order to make decisions for staffing next year.
