# K-9 Status Update

#### Curriculum

- First year of implementation 2016/17
- Curriculum will be maintained and reviewed on a regular, ongoing cycle
- Instructional samples and resources have been posted; more to come
- Curriculum for 9 second languages now available online

#### Assessment

- FSA 2017/18 1<sup>st</sup> administration from October 2, 2017 to November 10, 2017
  - FSA Samples and Specifications have been posted
  - FSA Scoring Guides and training papers now posted
- <u>K-9 classroom assessment</u> resource materials are in planning and initial design phase



### K-9 Status Update - continued

#### Reporting

- July 2016 reporting order remains in effect
- Provides options for districts as they implement new K-9 curriculum
- Developing the final provincial reporting policy:
  - Parent engagement data (online & in-person)
  - Jurisdictional research
  - School district scan (current & evolving practices)
  - Feedback from reporting experts and teachers
- Reporting Key Findings To Date:
- Parents want a better understanding of their child's progress through rich, personalized timely feedback and examples
- Flexible to meet the needs of parents and students
- Digital strategies allow parents greater access to information

\*\*\* Curriculum content will continue to be slightly revised until finalized in Spring 2018: course codes will be in place regardless

### **Mathematics**

- Revised core Mathematics courses, based on feedback.
  - Continued work on alignment of Big Ideas and Curricular Competencies.
- Course structure is set.
- Course credits will remain the same.



### Science

- Feedback continues to be considered
  - Already revised Chemistry and Physics at the 11 and 12 level
  - Already created a flexible, specialty science course for grade 12 (to allow modular course delivery)



## **Social Studies**

- All current draft (grade 11) courses posted online will be re-designated as grade 12
- A new social studies 11 exploratory course is under development
  - Not a mandatory course
  - Could be the 4 credit course for graduation
- A new Francophone History 11 course is in the planning stage
  - Not a mandatory course
  - Could be the 4 credit course for graduation

- Second language template is under redesign


#### **Career Education**



#### English Studies 12

#### Content

- This new course replaces English 12, although it differs in its purpose and content.
- · All students are required to take English Studies 12.
- This comprehensive course represents essential learning in ELA for student success within and beyond school.
- It ensures that students are exposed to the discourse related to a full range of texts (e.g., critical literacy skills associated with engaging with literary, digital, and informational texts).
- The Big Ideas of the curriculum ensure deep and transferrable understanding of key ELA concepts.
- It includes a greater focus on the importance of identity, place, culture, and multiple perspectives and on the appreciation of story and informational text.
- First Peoples texts, worldviews, and Principles of Learning are embedded throughout.
- Students learn to contribute to Reconciliation in Canada by building greater understanding of the knowledge and perspectives of First Peoples.
- The theoretical underpinning of constructivism remains.
- The continuum of learning that takes place in earlier grades of the ELA curriculum continues and is completed in Grade 12.

#### Skill Development

- 24 high-level Curricular Competencies address the development of language, literacy, and communication abilities, and creative and critical thinking.
- The required content supports the development of ELA curricular competencies.

# Numeracy

Numeracy is the ability, willingness, and perseverance to interpret and apply mathematical understanding to solve problems in contextualized situations, and to analyze and communicate these solutions in ways relevant to the given context.

# Literacy

 Literacy is the ability and willingness to make meaning from text and express oneself in a variety of modes and for a variety of purposes. Literacy includes making connections, analyzing critically, comprehending, creating, and communicating.



### **Structure of Provincial Assessments**

#### Activate Thinking/Collaboration Component

The Graduation Assessments begin with an activity to engage students and build connections to their knowledge and experience.

#### Common Component

The Graduation Assessments include engaging and interactive questions that all students will answer.

#### Student-Choice Component

The Graduation Assessments provide students with choice; students select a path that allows them to highlight and use their strengths.


#### Self-Reflection Component

The Graduation Assessments conclude with students reflecting on and analyzing their own experiences in the process and in the assessment tasks.





  - 8 = Science 10 (4 credits)
  - 9 = Science 11 or 12 (4 credits)
  - 10 = Physical and Health Education 10 (4 credits)
  - 11 = Arts Education and/or Applied Design, Skills and Technology 10, 11 or 12 (4 credits)
  - 12 = Career Life Education (4 credits)
    - 13 = Career Life Connections (4 credits)
    - \* If more than one course is designated as meeting requirement 1, then 2 credits from each course are being counted toward the requirement.
- In addition to the above 13 requirements, students need 28 credits for Elective Courses. Minimum 16 of 80 credits, including Language Arts 12, must be at the Grade 12 level. Plus, students must meet the Literacy Graduation Assessment requirement (15) and the Numeracy Graduation Assessment requirement (16).

All Grade 10 and 11 courses are reported as Final % only, even for courses where an exam might have been written.

#### **Graduation Program: General Update**

- Students entering Grade 12 in 2017/18 are in the 2004 Grad program:
  - Their graduation requirements have not changed
  - They will complete the LA12 Provincial Exam
- July 1, 2018: the 2018 Graduation program will come into effect. During their graduation years (10-12), students will:
  - Write two new provincial assessments (numeracy and literacy)
  - Complete 8 credits on Career Education
  - Need 80 credits in order to graduate, including 52 required course credits and 28 elective credits



## **Board/Authority Approved**

- 2017/18: no policy changes
- 2017/18: planned changes to this policy, to ensure alignment with new provincial curricula, will be communicated in 2017/18 and take effect July 1, 2018
  - Allows staff to review their existing BAA courses
  - New provincial curricula will replace some existing BAA courses
  - All remaining BAA courses that Boards wish to offer in 2018/2019 or beyond should be revised by July 1, 2018 to reflect the "Know-Do-Understand" design of the new provincial curricula
- Updated Ministry BAA resources to support this work will be available on the Ministry's <u>BAA website</u> in September



# Independent Directed Study

- Proposed Direction
  - No policy change required
  - Explore the idea of scheduling of IDS in the timetable
  - Support development of IDS resources and sharing of templates



### IDS, Equivalency, Course Challenge

- 2017/18: No policy changes
- Fall 2017/18: Minor changes to these policies, to ensure alignment with new provincial curricula, will be communicated and take effect July 1, 2018



#### External Credentials, Credit for Post-Secondary Course Completion ("Dual Credit")

- No policy changes effective for the 2017/18 school year
- The External Credentials Program and Dual Credit policy are under review to ensure alignment with current changes to curriculum and assessment
- Engagement with education stakeholders is scheduled for this fall
- Any changes will be communicated in 2017/18 and take effect July 1, 2018



## **Course Challenge**

- Challenge based on assessment of Big Ideas, Curricular Competencies and Content
- Ministry guidelines to state that 'Challenge processes should be substantial, but not onerous'
- Transfer Standing for course challenge is not an appropriate mechanism; robust challenge processes do result in ability to assign letter grades and percentages



## **Provincial Scholarship Program**

- 2017/19: there are no changes to the Provincial Scholarship Program or to scholarship eligibility criteria
  - Counsellors and administrators should continue to advise students as usual when helping them to prepare their post-secondary applications.
- The Ministry will provide clear details about any changes to scholarship eligibility and criteria well in advance to allow students ample time to prepare

## **Adult Education**

- On August 8, Premier Horgan announced restoration of ABE funding.
- Restores 2014 policies for graduated adults in K-12 system:
  - Tuition-free access to 36 approved academic upgrading courses
  - Districts will receive 50% on enrolment and 50% on completion, as defined in policy.
  - Takes effect for new course enrolments on or after September 1, 2017.
- The course list will be revised in the coming year to align with Learning Modernization Project and stakeholder feedback.
- Foundation courses and courses for non-graduated adults working towards a Dogwood are already tuition-free.

#### **Change Management & Provincial Engagement**

- Build understanding and support for the transformation among critical stakeholders (K-12 sector, PSIs, parents, students, and industry). Focus for 2017-2018:
  - Sector Check-in: Distribute sector readiness check-in on planned changes to 10-12 curriculum and graduation assessments
  - Build Support: Continue regular communications with partners and interested stakeholders when resources and support materials are available
  - Build Capacity: Identify and establish a network of change leaders to engage locally with educators, parents and students
  - Monitor: Work with partner groups (eg. Learning Advisory Board) to monitor change outcomes and address emerging issues





#### **Engagement with Post Secondary Institutions**

Working jointly with the Ministry of Advanced Education to engage with Post Secondary Institutions (Association Presidents, Vice Presidents, Registrars and Faculty)

Primary areas of interests include:

- Implementation Schedule: Alignment between sector timelines and PSI's review and approval process
- 10-12 curriculum: ELA 11 & 12, Math, Science & Socials Studies are of most interest
- Graduation Aassessments: Interested in how the results will be recorded on the transcripts
- Teaching and Learning for Faculty: Interested in how PSIs prepare for a different type of learner
- Next Steps: Work with the Ministry of Advanced Education, BC Registrars & Se Associations to host Implementation Forum (Fall 2017)


