Introduction

In exercising its governance and oversight functions, pursuant to Board Policy 621, the Board receives financial updates periodically throughout the year, at meetings of the Board held in public. This memorandum provides reports about the District's finances, for the period ended April 30th, 2022.

^{*}Note: actual operating fund expenditures as at April 30, 2020 are ~\$224,751 lower than the \$7,922,258 shown in the attached Monthly Operating Fund Expenditure Report as there are outstanding journal entries for distribution and accruals that were not in the accounting system as at April 30, 2022.

As at April 30th of the current year, the District had spent 78% of its Amended Budget, as compared with 72% at the same time in the prior year. April 30th is 10/12th of the way through the year and given that most salary and benefits expenses are incurred from September onwards, the 78% is in line with the budget. In the prior year, the District ran a significant surplus and spent less than budgeted, which largely explains why there was 28% remaining at the same time last year.

^{*}Note: the budgeted operating fund expenditures in the amended budget are \$9,888,010, as compared with the \$9,788,262 in the original annual budget, which is shown on the attached year-to-date Monthly Expenditure Report.



Accumulated Operating Surplus

The District's accumulated operating surplus at the beginning of the year was \$2,124,530, comprised of \$1,034,530 unrestricted surplus and \$1,090,000 in restricted surplus. This year's Amended Budget adopted by the Board on February 15, 2022 forecasts an operating deficit of \$306,803, which would reduce the Accumulated Operating Surplus at year end to \$1,817,727

Special Purpose funds are largely being spent in line with the Amended Budget.

Ready, Set, Learn expenditures are currently underway, and are expected to be fully spent by June 30, 2022.

Schools will spend significantly less than budgeted, although greater than average spending does occur in the final two months of the year for field trips, activities and graduation.

Seamless Day funds will not be fully used this year and will be caried forward to next year.
