# 6. Superintendent's Report

## A. <u>Music Program Update</u>

Superintendent Dubinsky introduced Diane Pare, music specialist who gave an update on the music program. She has spent the last 4 months working with K-7 students and is looking at how to expand music, in the future, to include secondary students. She reported students receiving new instruments, a digital library being compiled and concert choirs among other new endeavours.

# B. <u>Middle-Years Development Instrument (MDI)</u>

Superintendent Dubinsky reported the District's MDI results for this year. He explained that the MDI is a self-reporting survey that asks children about their thoughts, feelings, and experiences in the school and community. MDI implementation started in 2009 and participation is voluntary. Grades 4-7 students in the district participated as well as some grad 5 and 6's. MDI looks at 6 areas including social and emotional development, physical health and wellbeing, connectedness, use of out-of-school time, and school experiences. He explained a snapshot of highlights and brief comparison to other districts.

A discussion ensued regarding the possibility of cohort tracking.
