A. BCSTA AGM Student Delegate Survey

There was a discussion about the merits of a proposed involvement of student delegates at the BCSTA AGM and whether or not the KBB Zone should separately respond to BCSTA. Trustee Murphy, zone president, shared some of the discussion at the provincial, and other Trustees contributed to the discussion. Points made included:

- The motion to include student delegates has passed, but we can potentially influence how their participation occurs. Should students speak to motions?
- Whether the point is for students to contribute to or expose them to the democratic process
- What costs will be, and how might they differ for different districts?
- Who pays for student participation? District or BCSTA?
- What connection might the student delegates participation have to a curricular course?
- The equity impacts and representation issues associated with participation.

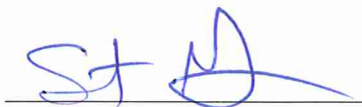
