## **BCPSEA's Budget**

Like School Districts, it is always a challenge in identifying and prioritizing BCPSEA's services and balancing our budget to address the labour relations and human resources needs of the sector. We have been fortunate over the past three years to get some additional temporary funding support from the Ministry of Education and Child Care, and the federal government.

#### **Key Highlights from the last year**

## **Bargaining:**

- BCPSEA has spent much of the last year preparing for bargaining. A lot of sector consultation has taken place and will continue today and tomorrow.
- In November, Justin Rempel joined BCPSEA as the new Executive Director, Collective Bargaining to lead bargaining for the sector. We are very excited to have his expertise.
- Teacher local bargaining is well underway. It opened on November 4, 2024, and will close on February 28, 2025.
- Bargaining for both provincial tables can start in March, which is just around the corner!
  Once we have dates set, we will share this information with you.
- School districts were provided with resources and training for local support staff bargaining.
  Most bargaining plans have been submitted to BCPSEA and are being reviewed.

# **Coordinated Legal & Arbitration Support Services (CLASS):**

Over the last several years, BCPSEA has implemented numerous strategies to help reduce the rising cost of legal and arbitration costs. Some of these measures include making greater use of associate-level legal counsel with external law firms, using in-house legal counsel, and instituting proactive and ongoing file reviews. In addition, starting this school year, BCPSEA introduced a usage-based component to the fee model. This fee model update is to allow school districts to influence their yearly CLASS program fees and encourage districts to participate in controlling legal costs at the local level.

#### Conflict of interest:

In October 2024, BCPSEA provided updated advice to boards of education on conflict of interest related to collective bargaining and administering the collective agreement. BCPSEA worked with external legal counsel, government and the BCSTA to create this updated guidance. We hope you find the new guide provides more clarity. In addition, BCPSEA issued another bulletin in January 2025 providing clarity regarding the issue of quorum.

#### Make a Future:

#### French recruitment:

The federal and provincial governments are continuing to support BCPSEA's French teacher recruitment program. Temporary funding has been provided until June 30, 2026. This new funding will expand services for direct candidate outreach and additional human resources recruitment services. The funding will also be used to enhance international recruitment efforts, strengthen candidate support, and continue French teacher marketing campaigns.

### Internationally educated teacher project

Make a Future in partnership with the Ministry of Education and Child Care is developing certification, immigration and employment resources for internationally educated teachers. The Ministry has provided funding to create a website section that will house these new resources, which will be launched this spring.

# Symposium:

The BCPSEA learning Symposium was held on November 8-9, 2024, in Vancouver. The main theme of the event was bargaining preparations. Roughly 260 people attended – thank you to all who came.

I would like to conclude by sharing my appreciation for our Board and for BCPSEA staff.
