- A. 2025-2026 Budget Update

The Secretary-Treasurer presented the monthly financial report. He noted that the District is operating within a tight budget due to \$319,000 less in operating revenue resulting from lower-than-forecast unique needs enrolment. He noted that various strategies are being pursued to reduce the deficit, including limiting operating fund expenditures on services and supplies, using in-house staff for minor capital projects, and deferring discretionary expenses to 2026-2027. He also reviewed year-to-date spending on capital expenses, including those funded as minor capital projects or by surplus appropriation.


