Principal Hibberson presented the NSS Hockey Course, noting the benefits to students and the funding to the district from the additional enrolment grants, which cover the ice-time expense. Zac Wethal described the program, noting its benefits to students, and thanked the seven community members who stepped up to help coach. Students Hudson Gascon and Noah Wethal noted that getting out of bed for early practices was the toughest challenge, but well worth it; they have seen significant skill improvement through skating five times per week with excellent coaching, including stick handling, creativity, discipline, and commitment.

Careers Teacher Tessa Wiseman presented the District's Dual Credit Programs. Students have benefits. There are now four partner colleges, providing numerous options locally and online. The dual credit courses can open up pathways and apprenticeships. The District provides individualized career support to students.


